

# DISCLOSURE REGARDING PROGRAM PREPARATION FOR PROFESSIONAL LICENSURE OR CERTIFICATION

The University of Louisiana at Lafayette is committed to providing clear and accurate information to current and prospective students to help inform career planning. The UL Lafayette program identified above prepares students to practice in a field with professional licensure or certification available. However, specific licensure and certification requirements can and often do vary by state. Requirements typically include earning a degree or other educational credential in the field from an institution and program that meet certain eligibility requirements in that state (e.g., curricular requirements, accredited status, approval by the state licensing board); passing a state or national exam; working in the field for a minimum period of time; and/or completing a certain number of clinical hours. If your career plans include pursuing professional licensure or certification in your chosen field, it is important to become educated on the credentialing requirements of the state in which you hope to practice.

#### **UL Lafayette Program Preparation in the State of Louisiana**

This certificate program fulfills the requirements for a Louisiana Department of Education add-on certification as an Instructional Coach; once completing the program, student must individually apply to the Louisiana Department of Education to officially receive the credential.

#### **UL Lafayette Program Preparation in Other U.S. States**

As a member of the National Council for State Authorization Reciprocity Agreements (NC-SARA), UL Lafayette is authorized to offer educational programs in all states (except California), the District of Columbia, Puerto Rico, and the U.S. Virgin Islands. The state of California is not currently a member of NC-SARA, but UL Lafayette is authorized to offer educational programming there as well.

We are currently unable to determine whether or not the above-named program meets the educational requirements for graduates to be eligible to apply for licensure or certification in any additional states.

If you have an interest in pursuing licensure or certification outside the state of Louisiana, we advise you to determine whether or not this program meets the educational requirements for graduates to be eligible to apply in that location. ### **UL Lafayette Program Preparation Outside the United States**
