The University of Louisiana at Lafayette is committed to providing clear and accurate information to current and prospective students to help inform career planning. The UL Lafayette program identified above prepares students to practice in a field with professional licensure or certification available. However, specific licensure and certification requirements can and often do vary by state. Requirements typically include earning a degree or other educational credential in the field from an institution and program that meets certain eligibility requirements in that state (e.g., curricular requirements, accredited status, approval by the state licensing board); passing a state or national exam; working in the field for a minimum period of time; and/or completing a certain number of clinical hours. If your career plans include pursuing professional licensure or certification in your chosen field, it is important to become educated on the credentialing requirements of the state in which you hope to practice.

UL Lafayette Program Preparation in the State of Louisiana

Educational Leaders must be certified by the state in which they work. Certification requirements may vary by state and educators must verify requirements with the certification officer in the state they are seeking certification. Students completing a Master of Education in Educational Leadership at UL Lafayette are prepared to seek these credentials.

Requirements set by the Louisiana Department of Education for **Educational Leader – Level 1 (Principals, Supervisors)** include:

- Passing the *Praxis School Leaders Licensure Assessment (6990)* with a score of 151+

Requirements set by the Louisiana Department of Education for **Educational Leader – Level 3 (Superintendents)** include:

- Passing the *Praxis School Superintendent Assessment (6991)* with a score of 162+
